## 3. Main new functionalities and minor changes

### 3.1 RN Consult PersonReference (REST)

To meet the needs of the TRIO webapp, development of a new generic RNCONSULT service (REST) allowing the display of minimal data based on a NISS, namely the first and last name of a patient.

### 3.2 RN Consult PermissionService (REST)

The goal of this service is to retrieve the list of services, data and their conditions linked, configured by eHealth Security.

Access to this service will be limited to all healthcare organizations (having a valid eHealth certificate) and recognized in the authentic source CoBRHA for RIZIV and EHP organizations.

### 3.3 DAAS

Therapeutic link and exclusion will be verified for the mult-eMediAtt project v3.

### 3.4 eAgreement V2

Service will allow an authorized health care provider to send these requests for agreement electronically and also to consult them and in particular Logopedists.

### 3.5 TRIO

As part of the “Return to Work Journeys”, a digital and secure collaboration platform called TRIO was created to promote collaboration between the different stakeholders involved in the context of reintegration into work.
